



Welcome to our August Newsletter

Like many of you, I'm sure, I haven't been doing much fishing over the last few weeks given the heat we've had, but I have had a couple of fantastic days at Draycote, catching 13 and 9 fish in the top of the water, pulling daddies and hoppers. I hear some people are catching well at Grafham as well! I'm sure with the water levels dropping and the dam being accessible that there will soon be some great bank fishing to be had at Grafham. Thanks to Mark Brinkman's working parties and work from the AW staff, the route to Sludge from the Plummer car park, known as Wyndhams Way, is now fully open - thanks to all involved for their hard work.

Tight Lines, *Lianne*

As Lianne has said there is not too much to report on the Grafham fishing front, given the current temperatures the boat take up is low and few bank anglers venturing out, the water temperature is still high. We have had a right mix for our club days this year from high winds to an almost tropical downpour at the members day to postponed dry fly day due to 38 deg flat calm conditions! The irony is that for many of our 'destination fishing' anglers they have travelled thousands of miles to hopefully have clear blue skies and wall-to-wall sunshine to stalk Bonefish etc only to be greeted by tropical storms, wind and rain, there is no certainty in fishing, but conditions do seem less predictable today.

For the early bird GWFFA bank anglers there are still quality fish to be caught even in the mid-summer high temperatures. I am not one of the early risers, but I did a couple of weeks ago get myself down to Pylon Point for a 7.30am start (note most serious early birds are contemplating going home by then!) It was overcast and a 12 mph SE wind, I immediately saw pods of 2 and 3 fish travelling just a few feet from the edge in shallow water picking off shrimp. I quickly had a pull, then landed 2 fish and dropped another couple. The wind then strengthened and went round to SW and the cloud cleared and the sun came out. By 8.30am the fish just faded away to deeper water. Great sport while it lasted, you just have to get up a bit earlier or fish late in the evening until the water temperature drops to trout acceptable levels. The boat fishing is more consistent as you can get out to the deeper water. With the shorter days and longer nights, we should see conditions improve and should not need too early a start to find the fish on the bank. We also now have unrestricted access to the Dam from Monday 11th August as the water levels are below the yellow line. It will be interesting to see how it fishes as reports from the boats have not had much success close into the dam.

Dog Flea treatments and their impact on water quality

There has been concern raised in the media about the impact of dog flea treatments on water quality and the impact on invertebrates, if you are a subscriber to the Fly Fishing and Fly-Tying Magazine it has an article highlighting concerns and impact on our rivers. Below is an extract from a Broads news website which highlights some of the concerns. This may also be affecting Grafham given the number of dogs being encouraged to swim in the water.

Research has shown that spot-on flea treatments which contain insecticides are posing significant risks to aquatic wildlife in waterways such as the Broads.

Many popular dog (and cat) flea and tick treatments contain fipronil, imidacloprid or similar chemicals. Fipronil and imidacloprid are powerful insecticides that are banned from agricultural use due to their harmful environmental effects but is still commonly used in pet products.

Other insecticides used as flea treatment may also be similarly harmful, but, as they have not been used as pesticides, they are not monitored in water and have had little research undertaken into their freshwater impacts.

The issue arises as the flea treatment doesn't just stay on pets. When dogs swim, get wet, or are washed (or we stroke them and wash our hands) this chemical can easily enter the waterways or drainage systems, causing impacts to aquatic ecosystems.

Why this matters for the Broads

Healthy wetlands such as the Broads rely on insects. Species like dragonflies, damselflies, and freshwater beetles spend much of their life underwater and are essential to the food chain. They are prey for fish, birds, and other wildlife - and help keep our rivers clean by filtering water.

However, these aquatic insects are extremely sensitive to pollution. Fipronil and similar chemicals persist on a pet's coat for weeks and can remain active for up to 90 days, even though they kill fleas within just 24–36 hours. As we stroke our treated pets, we can also contaminate our hands with these chemicals and the health risks associated with long-term exposure are unknown.

Once in the water, these insecticides can wipe out aquatic invertebrates and disrupt the delicate balance of our wetland ecosystems. The degradation rates of these chemicals in the environment are uncertain but may be months or longer.

UK studies and testing have shown that fipronil and similar chemicals are being found in rivers across the UK at concentrations known to harm wildlife.

Sources of contamination

After applying a spot-on flea treatment containing fipronil, there are a number of ways that it can enter the water system, for example:

By allowing a treated dog to swim in the rivers or broads.

Washing a treated dog, either at home or at professional groomers, where the wastewater ends up at a sewage treatment plant (which are unable to remove insecticides before they discharge water into the environment).

Washing pet bedding in household laundry.

Washing your hands after petting treated animals.

What can pet owners do?

Consider non-toxic flea and tick treatments, such as those containing dimethicone, which work by physically immobilising parasites rather than poisoning them.

Choose oral chewable tablets that offer protection against fleas and ticks but don't contain insecticides.

Do not allow your dog to enter lakes, ponds, rivers or ditches if you have treated them with a spot-on flea treatment in recent months.

Use flea and tick treatments only when necessary - not all pets require year-round use.

Government's new plan to tackle pet treatment chemicals in waterways

A new initiative has been launched (22 July 2025) by the Cross-Government Pharmaceuticals in the Environment Group to address water pollution from pet treatments. The roadmap proposes research to better understand the issue and inform updates to international environmental risk assessment guidelines.

The plan includes three main stages aimed at lowering pollution levels while maintaining animal welfare standards:

Communication & education: Raise awareness among pet owners and vets about proper use and disposal of flea and tick treatments to reduce environmental contamination.

Evidence gathering: Conduct research to understand how fipronil and imidacloprid enter waterways and assess their impact on ecosystems.

Regulatory actions: Use scientific findings to inform international guidelines and explore new regulations that protect the environment while maintaining animal welfare.

Links and further information on how you can help

Insect loss affects the whole food chain. A water beetle could be eaten by a fish such as a roach, which in turn is then eaten by a kingfisher. If populations of creatures at the bottom of the food chain are harmed, it can have significant impacts on animals further up the chain.

By making more informed choices, we can protect these intricate ecosystems and the incredible species that depend on them.

This is clearly a concern for Grafham and other Anglian water reservoirs as dogs are regularly encouraged by their owners to swim in the water, doubtless some will have been treated for fleas. We as a club will consider bringing this to the attention of the angling trust to seek their opinion.

There is a lot more information available on the internet just by searching on the chemicals mentioned above.

This year's bank clearance programme has got off to a good start, we have focussed to date on re clearing the path known as Wyndham's Way. This runs from the west end of Plummer car park right to the point of the Sludge bank. It was one of the last places cleared last year but the weed growth this year has been exceptional, we had to fight our way through brambles and stingers, impassable with a rod set up. Now you can walk in comfort the whole way. We have also repaired the second bridge which has been for years just a single plank (if you could see it through the undergrowth) now a three-plank bridge with no concerns of ending up in the stream! You may recall the last time the water levels were really low in 2022 Sludge Point and Sludge Bank was one of the top bank fishing locations. We might see the same this year!
